## SOME QUESTIONS REGARDING THE PREVENTION AND COUNTERACTION OF DOMESTAC VIOLENCE IN UKRAINE

One of the most important prerequisites of human life is health; protection of life, freedom and health is enshrined in the Basic Law of Ukraine - the Constitution. Violence is one of the most serious forms of violation of human rights and the most serious and also the most common in criminal and administrative offenses. Today, in Ukraine and in the world, the fight against domestic violence is quite relevant. According to the data of the National Social Service in Ukraine, only in the first half of 2021, 86,955 complaints were received from women about domestic violence against them. In our country, the authorities actively take measures to combat,

prevent and prevent domestic violence. The National Police is an advanced body of the executive power, which is authorized to consider domestic violence cases, which is based on the Law of Ukraine "On Prevention and Combating Domestic Violence" (adopted by the Verkhovna Rada of Ukraine on December 7, 2017). Also, the Code of Ukraine on Administrative Offenses and the Criminal Code of Ukraine have made changes and additions regarding fines and punishments for committing any domestic violence. In addition to the above-mentioned measures, a number of special measures are used to combat domestic violence:

- 1) an urgent injunction against the offender;
- 2) a restraining order against the offender;
- 3) taking the offender into the preventive register and carrying out preventive work with him;
  - 4) sending the offender to undergo a program for offenders [3].

In accordance with the Law of Ukraine "On Prevention and Combating Domestic Violence", victims are provided with assistance, rights and protection defined by the relevant law. Fortunately, the legislative, executive, judicial - society began not to be silent about the perpetration of violence in the family, and also to help other citizens who suffered because of the perpetration of domestic violence against them. It should be noted that prevention of domestic violence is carried out in Ukraine by authorized bodies of the National Police, institutions of the education system, authorized bodies, institutions and health care institutions in the field of prevention and counteraction of domestic violence, authorized centers for providing free secondary legal assistance in the field of prevention and countermeasures against domestic violence, authorized by general and specialized support services for victims [3].

In our opinion, the problem of committing domestic violence can be prevented and even overcome if society stops thinking that this problem is a topic for only two people and it is not only possible, but necessary, to ask for help from the bodies authorized to deal with this problem. It should be remembered that the state takes care of its people and takes measures for the sake of safety and protection of society.
