The circumstances identified by us give us the opportunity to think about further improving the provision of forensic equipment and recommendations for improving the activities of law enforcement in the modern conditions of combating illegal activities.

Thus, we can conclude that the role and importance of criminology are no less important than all others among other sciences, because thanks to this relevant knowledge, skills improvement improves and increases the efficiency of law enforcement, and it becomes easier to investigate and establish all the circumstances. committed criminal offense and assessment of the actions of each of its participants. Advances in science and technology, analysis of ways of committing criminal offenses, proper assessment and taking measures to overcome the opposition to pre-trial investigation require constant improvement and implementation in practice.

Since a different number of samples is required in each case, it is difficult to give uniform and accurate recommendations for all types of handwriting examination [4].

Thus, the study of auto-forgery presents certain difficulties, given the manifestation of a complex of signs indicating the execution of signatures by other persons (by eye, visually observing a controversial signature, etc.). However, you should consider the ways of performing from full to partial

signature changes. Awareness of the pre-trial investigation authorities regarding the methods and signs of deliberate distortion of the signatures of offenders, will make it possible to prepare expert examination materials in a high-quality manner and obtain an expert opinion in a timely manner.
